points on appeal pursuant to AS 15.20.510 and Alaska R. App. P. 204(e) as numerous
errors have been made in the Primary Election Recount for House District 40:

1. Whether malconduct on the part of an election official sufficient to change the result of an election occurred in the precinct of Kivalina, AK.
2. Whether malconduct on the part of an election official sufficient to change the result of an election occurred in the precinct of Buckland, AK.


3. Whether the numerous serious violations of law in House District 40, not individually amounting to malconduct, were such that the cumulation of those irregularities supports a finding of malconduct.
