**JOINT MOTION FOR SCHEDULING ORDER WITH EXPEDITED
CONSIDERATION OF CROSS SUMMARY JUDGMENT MOTIONS**

The Plaintiffs, Bill Wielechowski, Rick Halford, and Clem Tillion (“Plaintiffs”) and the Defendants State of Alaska and Alaska Permanent Fund Corporation (“State Defendants”) jointly agree that it is in the public interest that this case be resolved promptly. It is undisputed that the State faces serious fiscal and budgetary issues due to the dramatic decline in public revenues. The governor and the legislature will be required to address these financial issues in the upcoming legislative session beginning in January 2017. This lawsuit challenges a veto of an expenditure of money equivalent to half of the revenue the State took in last year, and thus the governor and legislature need clarity on the legal issues pertaining to expenditure of permanent fund income to productively budget and legislate in the coming session. Keeping in mind that one or both parties may choose to seek an expedited appeal following any superior court
